Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Habeas Corpus calling for the entire records relating to petitioner's son detention under Tamil Nadu Act 14 of 1982 vide detention order dated 19.04.2018 on the file of second respondent herein made in proceedings BCDFGISSSV No.239/2018 and quash the same as illegal and consequently direct the respondents herein to produce the said petitioner's son namely Mani (a) Manikandan S/o.Kesavan, aged 26 years before this Court and set the petitioner's son at liberty from detention, now petitioner's son detained at Central Prison II, Puzhal, Chennai - 600066.

Learned Additional Public Prosecutor would submit that the detention order passed against the son of the petitioner in BCDFGISSSV No.239/2018 dated 19.04.2018 on the file of the second respondent is revoked vide G.O.Rt.No.2141, Home, Prohibition and Excise (X) Department, dated 01.06.2018 and produced a copy of the said order.

In view of the above, this petition is closed as it has become infructuous.
