Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus calling for the records of the impugned proceedings dated 09.10.2013 in Na.Ka.No.0158/A3/2013, on the file of the 2nd respondent, and quash the same, directing the respondents to grant recognition for a period of three years, from 01.10.2012 to 30.09.2015 under the Code of Regulations of Matriculation Schools, for the San Jose Matric.Hr.Sec.School, kattoor, Mettupalayam-641 305.

O R D E R

The order impugned dated 09.10.2013, in respect of the certificate of recognition granted to the writ petitioner/School from 01.10.2012 to 30.09.2015, is under challenge.
