This Court while granting Interim Stay by order dated 26.4.2018 directed the appellants to deposit 50% of the award amount, within a period of four weeks. Thereafter, this matter on several occasions came up for hearing. Though the learned Government Advocate appearing for the appellants took time to make the deposit, till date the deposit has not been made as directed by this Court.

2.Hence, this Court does not find and reasonable entertain the prayer for extension. Accordingly, this petition is dismissed.
