1. The Writ Petition has been posted under the caption "being mentioned" today and the Writ Petition has been filed seeking for a direction to the respondent permitting the petitioner trust to submit their application for building permission through online as per the G.O.Ms.No.76, Housing and Urban Development [UD4 (3)] Department, dated 14.06.2018.

2. Wherein in para 2 of the order, it is stated that the petitioner trust is proposed to construct the building for the educational institution and for that purpose, they have made application. In fact, the petitioner has already constructed the building and they are seeking the relief as per G.O.Ms.No.76, Housing and Urban Development [UD4 (3)] Department, dated 14.06.2018, but in the order, it was wrongly mentioned that the petitioner has proposed to construct a building and hence, for correcting the said order, now the writ petition is posted today.
