Prayer:- This Writ Petition is filed, under the Article 226 of Constitution of India, to issue a Writ of Certiorarified Mandamus, to call for the records of the 2nd Respondent culminating in his impugned order bearing in Lr.No.SE/UEDC/UDT/AO/R/AS/AS2/F.HT SC 128/ D.No. 111/2010, dated 22.01.2011 and to quash the same and to direct the Respondents not to proceed to collect any amounts from the Petitioner on the ground that the meter provided to HT SC No.128, was defective, without referring the issue to an independent accredited laboratory, by following the procedure prescribed by the Tamil Nadu Electricity Regulatory Commission in its Order, dated 08.09.2009 in MPM No.41/3, the Central Electricity Authority (Installation and Operation of Meters) Regulations, 2006 and National Electricity Policy.
