2.The Learned Special Government Pleader for the Respondent/Contemnor has made an endorsement in the Writ Petition No.3375 of 2018 to the effect that the Respondent is withdrawing the Notice, dated 06.07.2018, issued under Section 6 of the Act 3 of 1905 and undertakes to take <https://hcservices.ecourt.gov.in/hcservices/> against the encroachers, in terms of the direction issued by this Court in W.P.No.3375 of 2018, dated



15.02.2018. The said submission is recorded.
