PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a Writ of Habeas Corpus, calling for the records in connection with the order of detention passed by the second respondent dated 28.05.2018 in C3/D.O/27/2018 against the petitioner husband Nirabu, male aged 28 years, S/o.Ramadoss, who is confined at Central Prison, Cuddalore and set aside the same and direct the respondents to produce the detenu before this Court and set him at liberty.

ORDER

[Order of the Court was made by C.T.SELVAM, J.]

The petitioner, who is the wife of the detenu herein, viz., Nirabu, son of Ramadoss, aged 28 years, has come forward with this petition challenging the detention order passed by the second respondent by his order in C.M.P.No.27/2018, dated 28.05.2018 against his husband branding him as a "GOONDA" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2. The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the husband of the petitioner herein dated 28.05.2018 has been revoked by the Government in G.O.Rt.No.2857, Home, Prohibition & Excise [XI] Department dated 12.07.2018 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this Habeas Corpus Petition is closed as the same has become infructuous.
