Learned Additional Public Prosecutor, would submit that the detention order passed against the detenu in No.359/BCDFGISSSV/2018 dated 30.05.2018 on the file of the second respondent is revoked vide G.O.Rt.No.2895, Home, Prohibition and Excise (XIII) Department, dated 12.07.2018 and produced a copy of the said order.

In view of the above, this petition is closed as it has become infructuous.
