complainant have amicably resolved the dispute between
themselves.

3. Both the learned counsel have identified the de-facto
complainant, who is present before this Court today. In order to
identify the petitioner 1 & 2 and the de-facto complainant, they
have submitted their photo copies of their Identity Cards
viz., 1.R.Ramesh - 564252194180 (Adhar Card), 2.C.Suresh -
966109157795 (Adhar Card) and 3.S.Hasina - 390722293920 (Adhar
Card) and after verification of the original, the same are
recorded.

4. Today, an Affidavit dated 07.03.2018 was also filed by the 2nd respondent / de-facto complainant to the effect that she has no objection to quash the proceedings in C.C.No.213 of 2016 on the file of the Additional Mahila Court, Permbalur.

5. Recording the same, the proceedings in C.C.No.213 of 2016 on the file of the Additional Mahila Court, Permbalur is quashed. The Criminal Original Petition is allowed.
