The first respondent is directed to consider the petitioner's representations dated 21.05.2018 and 13.06.2018 and pass appropriate order, after giving an opportunity to the petitioner, within a period of two weeks from the date of the receipt of a copy of this Order.

5. With the above direction, this writ petition is disposed of. Consequently, connected miscellaneous petition is also closed. No costs.
