The petitioner seeks for a mandamus directing the respondents 1 to 3 to consider here representation dated 08.02.2018, wherein and whereby, she sought for disconnection of electricity power supply given in the name of the fourth respondent in respect of the property at No.44/2, Thatchi Arunachala Mudali Street, Chennai-600 004.

3. According to the petitioner, she is the owner of the subject matter property and the fourth respondent is a trespasser.

4. This Court, at this stage, is not expressing any view on the merits of the claim made by the petitioner, as it is for the first respondent to consider and decide the same.
