Liberty sought for by the petitioner is granted and the Court of Principal District Munsif at Gingee, on entertainment of the Interlocutory Application for ad-interim injunction, shall accord priority and dispose of the same at an early date. No costs. Consequently, connected miscellaneous petition is also dismissed.
