It is represented by the learned counsels on either side that after filing this Writ Petition, the sixth respondent has handed over the possession of the disputed site to the Temple and the prayer sought in the Writ Petition has become infructuous.

3. In the light of the above fact, this Writ Petition is dismissed as infructuous. No costs. Consequently, connected miscellaneous petition is closed.

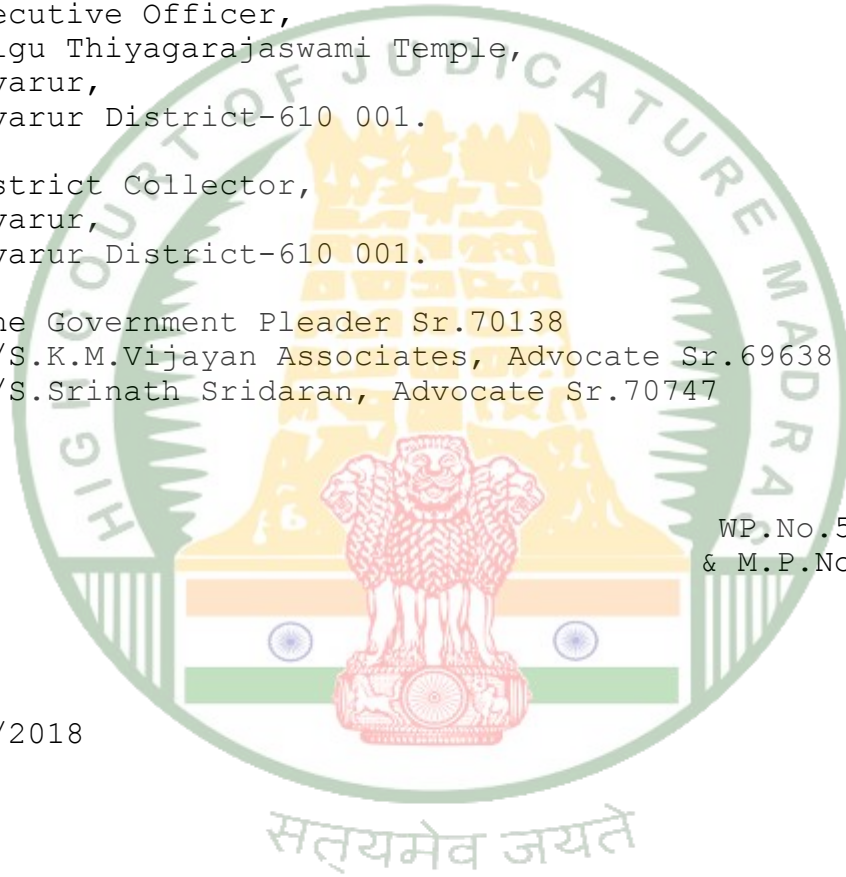
