Therefore, she seeks permission to withdraw the writ petition. Permission is granted. Writ petition is dismissed as withdrawn. No Costs.

3. Though, a request has been made to file a fresh writ petition on the same cause of action, request is declined.

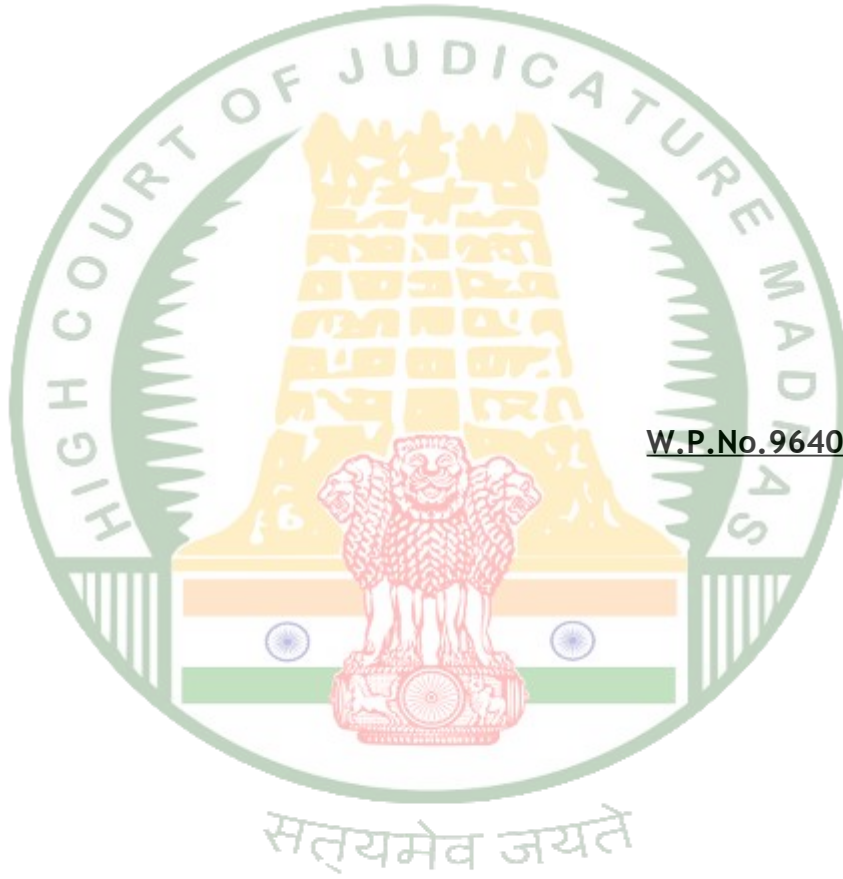
