Recording the submissions of learned counsel for petitioner as also learned Additional Public Prosecutor that in compliance to the order dated 15.02.2018, the detinue viz., Sivapriya has presented herself before the Superintendent, Central Prison, Puzhal-III, (Women Prison), Chennai and is now in judicial custody, this Habeas Corpus Petition shall stand closed.
