4.In such view of the matter, the petitioner is directed to cooperate with the police for enquiry and at the time of conducting enquiry, the petitioner shall not be harassed. During the course of enquiry, if any cognizable offence is made out, the 3<sup>rd</sup> respondent police is free to register an FIR and this order shall not be a shield for the petitioner against arrest.
