Writ Petition filed under Article 226 of The Constitution of India seeking for issuance of Writ of Mandamus directing the respondents 1 and 2 to pass orders on the representation submitted by the petitioner dated 02.01.2018 for cancellation of appointment of 3rd respondent as Driver in the 2nd respondent Corporation on compassionate grounds obtained in suppression of regular employment of the 3rd respondent's brother V.Ilayaraja in the respondent Corporation and consequently direct the 2nd respondent to promote the petitioner in the post of Driver retrospectively w.e.f. 15.03.2017 with all consequential benefit, within a time frame to be fixed by this Hon'ble Court.

ORDER

This Writ Petition has been filed seeking issuance of Writ of Mandamus directing the respondents to consider the petitioner's representation dated 02.01.2018 seeking cancellation of appointment of third respondent as driver in the second respondent Corporation, who was appointed on compassionate grounds, concealing the employment of his elder brother V.Ilayaraja, who was appointed as Sanitary Worker on 04.05.2001 and got regularisation on 30.04.2001, presently working in the second respondent Corporation.

2.Heard the parties on both sides.

3.This Court, finding *prima facie* merits, accepting the request of the learned counsel appearing for the second respondent and the request of the first respondent, directs the second respondent to consider the petitioner's representation, after issuance of notice to the third respondent and pass orders on merits within a period of four weeks from the date of receipt of a copy of this order.

The Writ Petition is disposed of accordingly. No costs.
