ORDER

2.Now, the present contempt petition has been filed by the petitioner alleging non-compliance of the said order dated 11.02.2016 passed by this Court.

3.Today, when the matter is taken up, the learned Government Advocate appearing for the respondents, by producing a copy of the proceedings dated 28.09.2017 issued by the 2nd respondent, submitted that the order of this Court has been duly complied with by the respondents.

4. Since the order of this Court has been complied with, nothing survives in the present contempt petition. Hence, the Contempt Petition is closed.
