Nagar to Mr.Syed Jaffer/1st respondent in W.A.No.1823 of 2018, through the Tamil Nadu Slum Clearance Board. Producing the said letter, the learned counsel submitted that he may be permitted to withdraw these appeals, as the matter in the appeals has become infructuous. An endorsement has also been made to that effect.

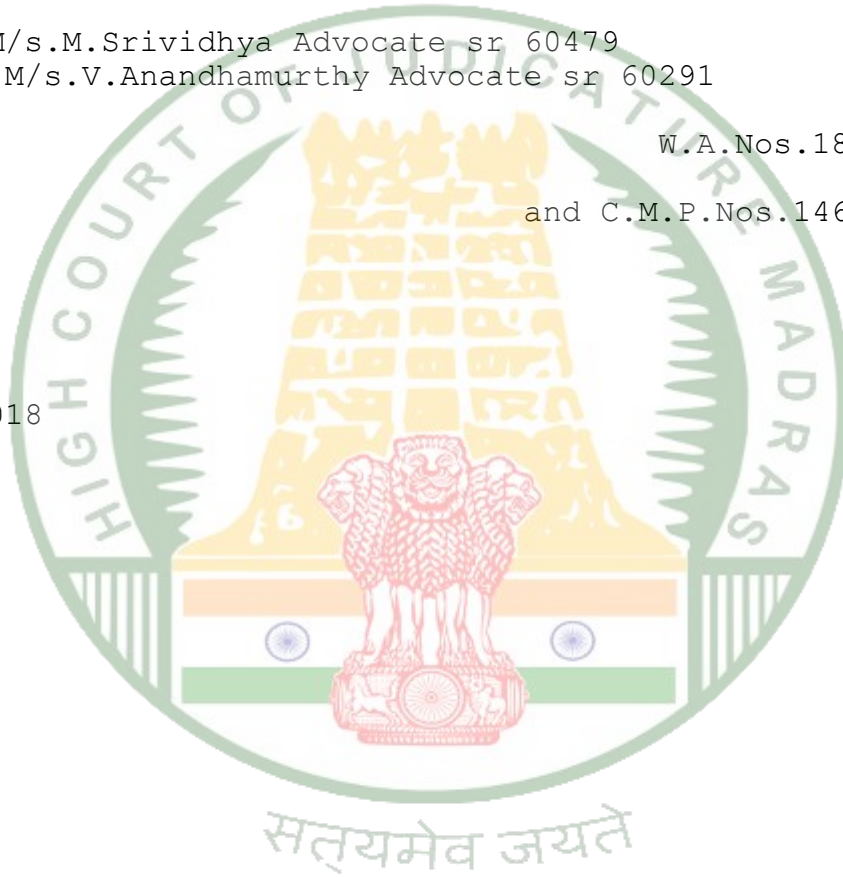
