2.Mr.Udhaya Kumar, learned Additional Government Pleader would draw the attention of this Court to paragraph 4 and 7 of the counter affidavit and submit that immediate action was taken to remove the encroachment made by the 7th respondent in Raja Vaickal and it was removed on 22.06.2018 and as on date, there is no encroachment.

3.Since action has already been taken as could be seen from the photographs produced before this Court, no further action is necessary. Hence, the writ petition stands closed. Consequently, connected miscellaneous petition is closed. No costs.

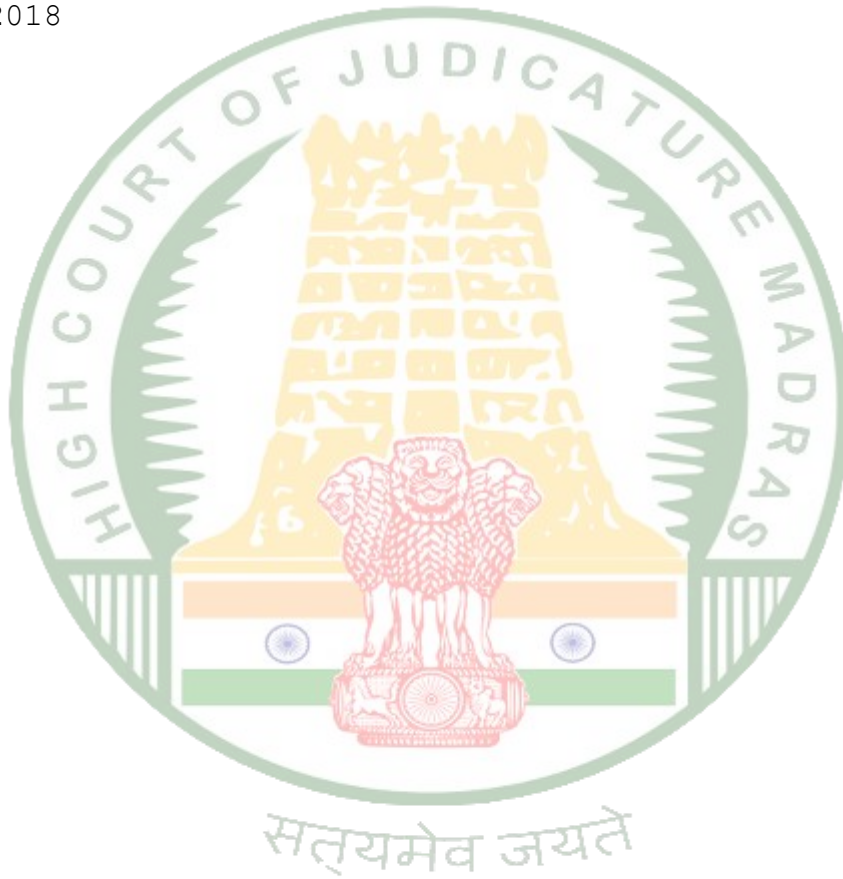
