3. The petitioner seeks for mandamus directing the

respondents to consider his representation dated 26.08.2017, wherein and whereby, he sought for issuance of Patta in respect of the land in Survey No.43/1 to an extent of 4.76 acre and Survey No.13/6 to an extent of 0.30 acres in Puliankunta Village, Veerarahavapuram Post, Tiruthani Taluk, Tiruvallur District.

4. The grievance of the petitioner before this Court is that the said representation has not been considered so far. This Court, at this stage, is not expressing any view on the merits of the claim made by the petitioner, as it is for the third respondent to consider and decide the same on merits and in accordance with law. Accordingly, this writ petition is disposed of, only by directing the third respondent to consider the representation of the petitioner dated 26.08.2017 and pass orders on the same on merits and in accordance with law, after hearing rival claimants, if any. Such exercise shall be done by the third respondent within a period of eight weeks from the date of receipt of a copy of this order. No costs.
