Taking into consideration the petitioner is regularly complying with the condition imposed by the XIII Metropolitan Magistrate at Chennai for the past 53 days, the condition imposed on the petitioner in CrI.M.P.No.87 of 2018 dated 31.01.2018 is modified to the effect that the petitioner shall report before the Villupuram Town Police Station, Villupuram, every day at 10.30 a.m., until further orders.
