Prayer: Writ Appeal filed under Clause 15 of the Letters Patent against the order dated 29.1.2016 passed in W.M.P.No.2713 of 2015 in W.P.No.3309 of 2016 on the file of this court, praying to grant an order of direction directing the respondents 1 to 4 herein to grant interim approval of the petitioners appointment as B.T.Assistant(Science) in the 5th respondent minority aided school without insisting for TET pass certificate and pay salary to him pending WP.No.3309 of 2016.

Prayer in WP.No.3309 of 2016:Writ petition filed under Article 226 of Constitution of India, to issue a writ of mandamus directing the respondents 1 to 4 to approve the petitioners appointment as B.T. Assistant (Science) in the 5th respondent minority aided school with effect from 01.06.2015 within the time frame fixed by this Honourable Court without insisting for TET pass certificate and pass such further or other orders.

JUDGMENT

Heard the learned Special Government Pleader appearing for the appellants and Mr.M.Saravanan, learned counsel for the first respondent and Mr.T.Sezhian, learned counsel for the second respondent, who take notice on behalf of the respective respondents.

2. The writ appeal has been filed by the State challenging the interim direction granted by the learned Single Judge directing the appellants to grant interim approval of the appointment of the first respondent herein as B.T.Assistant (Science) in the institution viz., the second respondent herein without insisting for TET pass certificate and to pay salary to him.

3. When the writ appeal was taken up for hearing, it was brought to the notice of the court that the order passed by the learned Single Judge has been complied with and hence, the writ appeal becomes infructuous.

4. In view of the above development, the writ appeal is dismissed as having become infructuous. No costs. The connected miscellaneous petition is also dismissed.

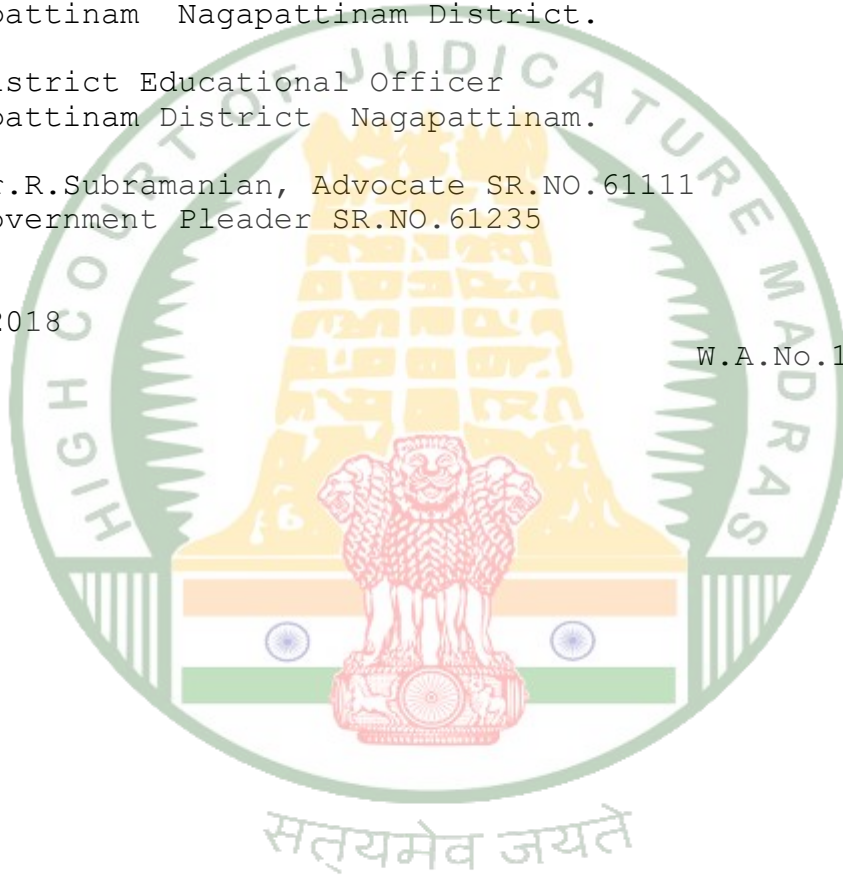
