This petition has been filed seeking to quash the proceedings in Crime.No.35 of 2011 on the file of the Inspector of Police, Central Crime Branch, Salem.

2.Pending Criminal Original Petition, the defacto complainant and the petitioners have amicably resolved the dispute among themselves and accordingly, they have entered into a compromise.
