2.Heard the learned counsel for the petitioners as well as the learned counsel for the second respondent and the learned Government Advocate (Crl. Side) for the first respondent.

3.The learned counsel for the petitioners submitted that the first petitioner/father-in-law of the defacto complainant had expired. He further submitted that pending proceedings in C.C.No.13 of 2015 on the file of the Mahila Court (Magistrate

Level), Coimbatore, the second respondent/de-facto complainant and the second petitioner have amicably settled the issue among themselves and the de-facto complainant has also filed a compromise affidavit dated 12.02.2018 stating that she has no objection if the proceedings in C.C.No.13 of 2015 on the file of the Mahila Court (Magistrate Level), Coimbatore is quashed.
