The prayer sought for in the present petition is to call for the records in C.C.No.958 of 2015 now pending on the file of learned XIV Metropolitan Magistrate, Egmore (Allikulam), Chennai and quash the same.

2. It is submitted that, pending Criminal Original Petition, the petitioners and the 2nd respondent/defacto complainant have amicably resolved the dispute between themselves.

complainant, who is present before this Court today. In order to identify the petitioners, they have submitted the photo copies of the parties in respect of their identity cards viz 1) Selvam P V - India Driving Licence (Tamilnadu) No.TN09 20000013688 2) 2) K.Barani Kannan - Aadhar Card No.4571 0761 6993, and 3) Chandrasekhar - - Aadhar Card No. 4208 7208 4934 and the defacto complainant has submitted the photocopy of his Aadhar Card viz.
