This petition has been filed by the petitioner / mother of the detainee seeking to produce her son, Jeya Sangeeth, aged about 33 years, before this Court.

2. Heard the learned counsel appearing for both sides.

On instructions, the learned Additional Public Prosecutor appearing for the respondents would produce the statement of the detainee, dated 12.05.2018, in which, the detainee has given a statement that he is married to one Sasikala and as it was not liked by his mother, and therefore, the detainee was staying away from the mother and he is staying in the place he liked.

4. The above statement is recorded. As there is no complaint of illegal custody, Habeas Corpus Petition is not maintainable. Hence, this Habeas Corpus Petition is closed. However, if the statement made by the detainee is found to be incorrect, it is for the petitioner to take action in accordance with law.
