The learned Master by his order dated 14-07-2015 allowed the said application on condition that the cost of Rs.300/- be paid by the petitioner to the Chief Justice Relief Fund on or before 21-07-2015. Since the petitioner failed to comply with the conditional order, the Application No.4605/2015 came to be dismissed.

4. Accordingly, this application is dismissed for default.

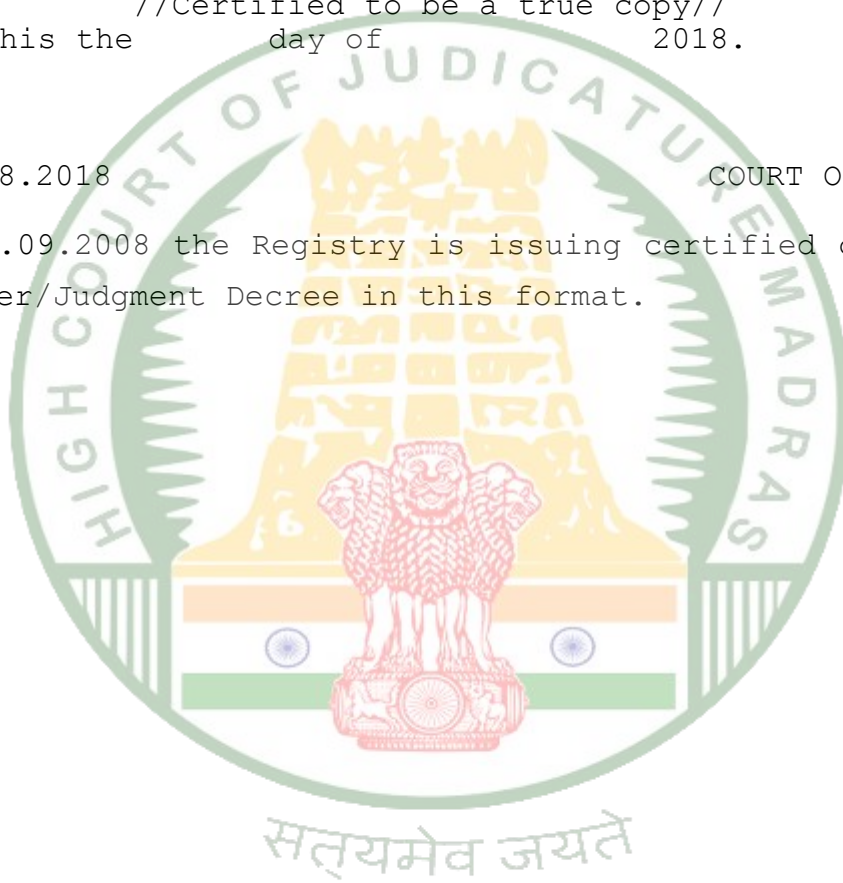
