PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a Writ of Habeas Corpus, calling for the records in connection with the order of detention passed by the 2nd respondent dated 10.07.2018 in No.501/BCDFGISSSV/2018 the son of the petitioner, detenu Murali, male aged 27 years, Son of Santhanam, who is confined at Central Prison, Puzhal and to set aside the same and consequently direct the respondents to produce the detenu before the Hon'ble Court and set him at his liberty.

ORDER

The petitioner, who is the mother of the detenu herein, viz., Murali, son of Santhanam, aged 27 years, has come forward with this petition challenging the detention order passed by the second respondent by his order in No.501/BCDFGISSSV/2018, dated 10.07.2018 against her son branding him as a "GOONDA" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic

Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2. The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the son of the petitioner herein dated 10.07.2018 has been revoked by the Government in G.O.Rt.No.3577, Home, Prohibition & Excise [XIII] Department dated 23.08.2018 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this Habeas Corpus Petition is closed as the same has become infructuous.
