While so, it is seen that a petrol bomb was thrown into the shop of the petitioner. Pursuant to which, a case in Melmaruvathur Police Station Crime No.104 of 2018 has been registered on 14.03.2018 under Section 285 of IPC against unknown accused. In such view of the matter, this Court directs the respondent Police to put a patta passbook at the residence of the petitioner and maintain surveillance so that, no harm befalls on the petitioner.
