JUDGMENT

(Judgment of the Court was delivered by M.M.SUNDRESH, J.)

This appeal is directed against the order dated 12.10.2017 made in A.No.3775 of 2016 in C.S.No.1364 of 1995.

2.When the matter is taken up for hearing, learned counsel appearing for the appellant submits that the suit itself has been dismissed for default. In view of the same, nothing survives for adjudication in this appeal. Accordingly, the original side appeal is dismissed as infructuous. No costs. However, liberty is given to the learned counsel for the appellant to make a mention for restoration of the appeal in the event of the suit being restored.
