PRAYER: Petition filed under Article 226 of the Constitution of India, to issue a Writ of Habeas Corpus, calling for the entire records, relating to the petitioner's brother detention order Tamil Nadu Act 14 of 1982 vide detention order, dated 19.02.2018 on the file of the second respondent herein made in proceedings Memo C.No.25/G/IS/2018, quash the same as illegal and consequently direct the respondents herein to produce the petitioner's brother namely A.Rajkumar @ Padayappa, S/o.Arumugam aged 23 years before this Hon'ble High Court and set the petitioner's brother at liberty from detention, now detained at Central Prison, Coimbatore.

ORDER

[Order of the Court was made by C.T.SELVAM, J.]

The petitioner, who is the brother of the detenu herein, viz., Ajithkumar @ Padayappa, aged 23 years, has come forward with this petition challenging the detention order passed by the second respondent by his order in C.NO.25/G/IS/2018, dated 19.02.2018 against his brother branding him as a "Goonda" under the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 [Tamil Nadu Act 14 of 1982].

2. The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the brother of the petitioner herein dated 19.02.2018 has been revoked by the Government in G.O.Rt.No.1228, Home, Prohibition & Excise [XII] Department dated 02.04.2018 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this Habeas Corpus Petition is closed as the same has become infructuous.

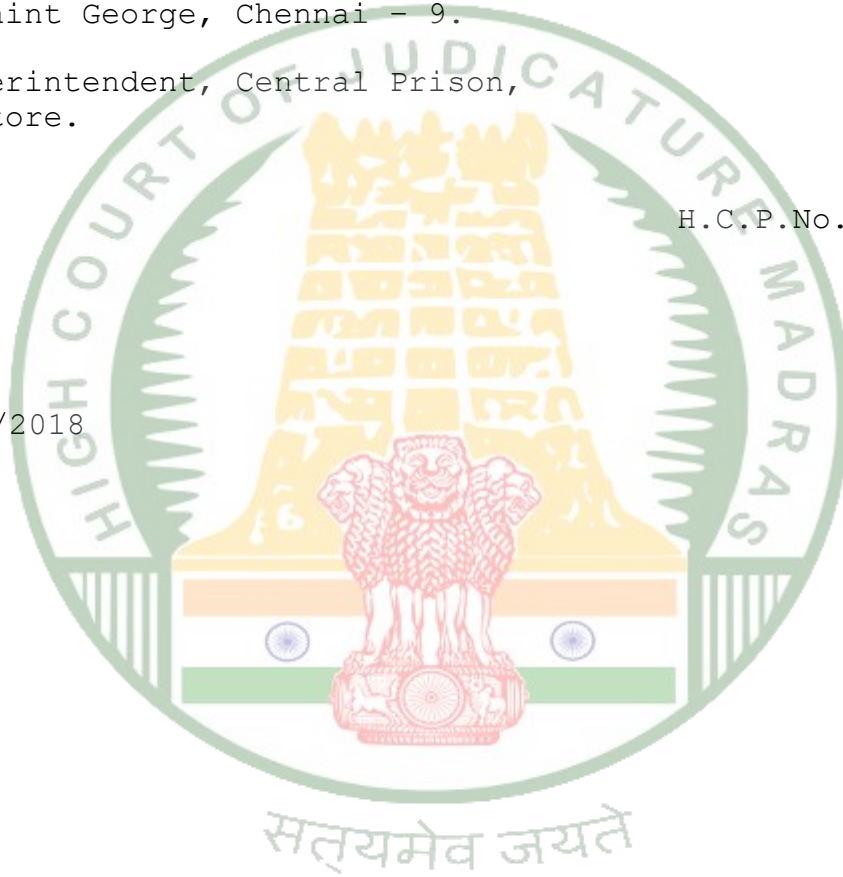
