dated 12.02.2016 registered as Document Nos.1161-1167 of 2016 on
the file of the Sub Registrar, Ponneri.

2. It is submitted by the learned counsel for the petitioner
that the respondents 2 to 4 herein have trespassed to the
property creating nuisance and disturbance and therefore he had
given the complaint on 05.01.2017, seeking for a protection.
Since the complaint has not been disposed within a reasonable
