2. When the matters were taken up for hearing, the learned Special Government Pleader appearing for the respondents, on instructions, submitted that the petitioners, without enclosing the required details regarding their identity, have sent their representations to the respondents through post.

In view of the submission so made by the learned Special Government appearing for the respondents, this Court is of the view that the petitioners, without approaching the authority concerned, have straight away come to this Court with the present writ petitions. Such sort of approach by the petitioners

cannot be countenanced. Hence, the relief sought for herein cannot be entertained by this Court.

4. Accordingly, these writ petitions are dismissed. No costs.
