Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Habeas Corpus calling for the records relating to petitioner's son detention under Tamil Nadu Act 14 of 1982 vide detention order dated 20.03.2018 on the file of second respondent herein made in proceedings No.159/BCDFGISSSV/2018 and quash the same as illegal and consequently direct the respondents herein to produce the petitioner's son viz., Anithkumar, S/o.Kannan, aged 31 years, before this Court and set the petitioner's son at liberty from detention, now petitioner's son detained at Central Prison II, Puzhal, Chennai - 600066.
