appropriate application before the court below to challenge the order dated 14.09.2017.

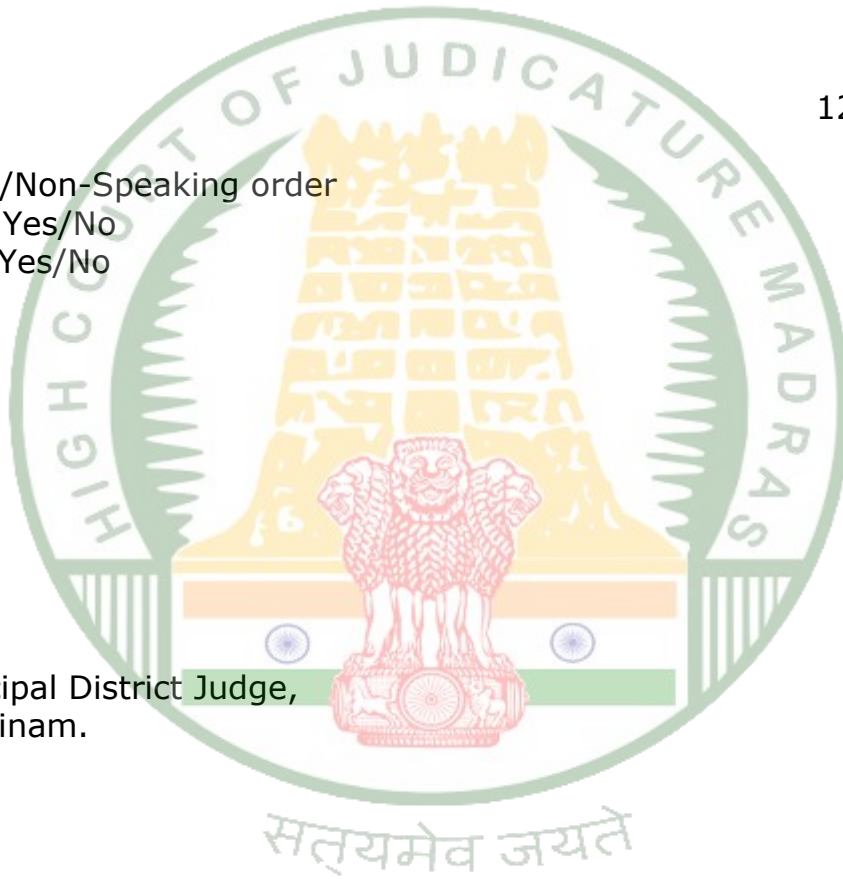
3. The Civil Revision Petition is disposed of with above direction. No costs.

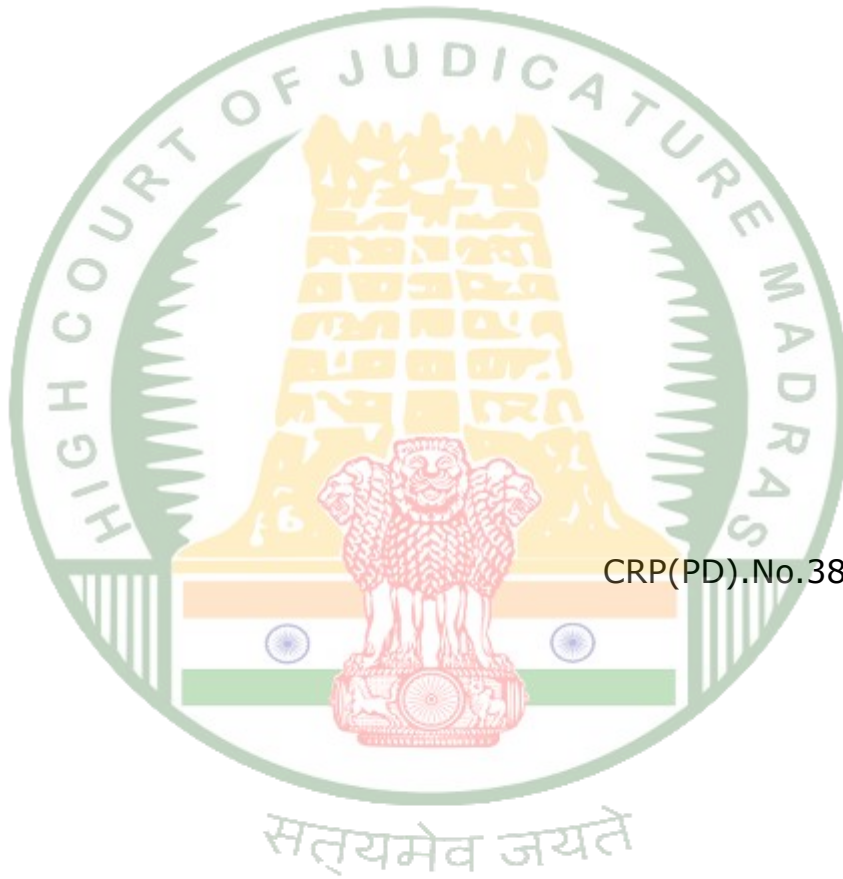
