Such exercise shall be done by the second & third respondents within a period of twelve weeks from the date of receipt of a copy of this order. No costs.

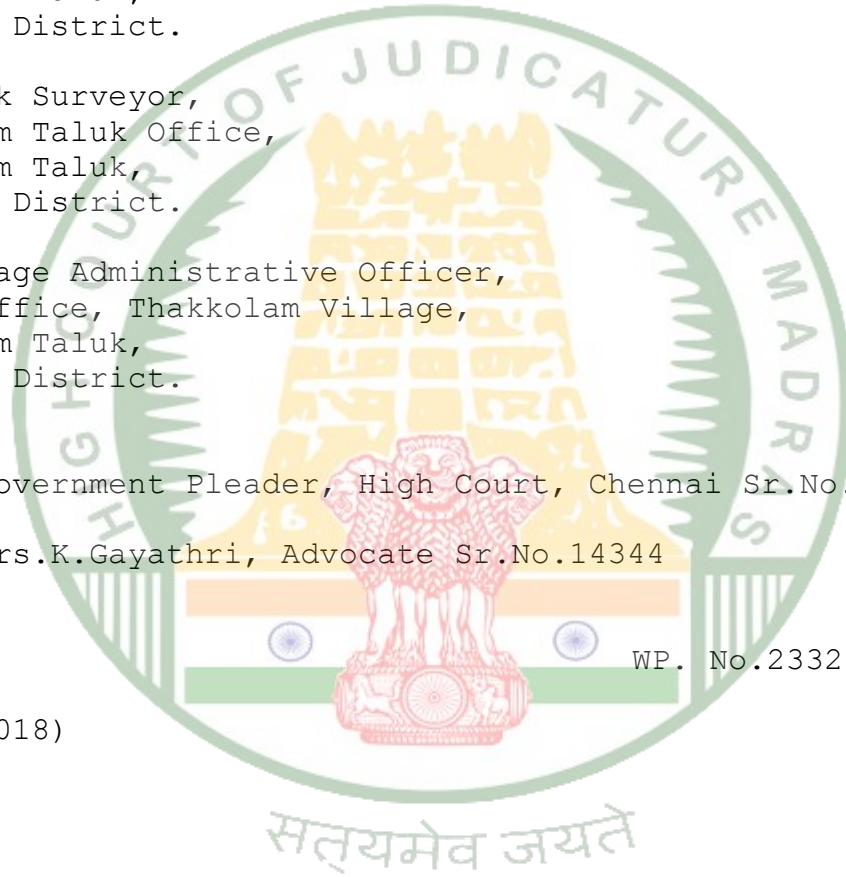
