2. Admittedly, the said property is a temple.

3. The learned Government Advocate, who is appearing for the

respondents states that the respondents do not intend to demolish the

temple or interfere with the petitioner's possession and enjoyment of the said property i.e. temple.

4. In view of the categorical statement made by the learned Government Advocate, it is not necessary for us to pass any further orders. Accordingly, the writ petition is disposed of. No costs. Consequently, the connected miscellaneous petition is closed.
