ii. For a Permanent injunction restraining the Defendants herein, their agents, servants or anybody claiming through or under them from in any manner infringing with the limited copyright of the plaintiff by distributing, exhibiting and exploiting the Tamil Talkie Picture Titled "BASKAR ORU RASCAL" (Colour-Scope-Digital) anywhere in the areas of Salem and Dharmapuri Districts as known in film trade or in any other manner whatsoever.

iii. For the costs of the suit.

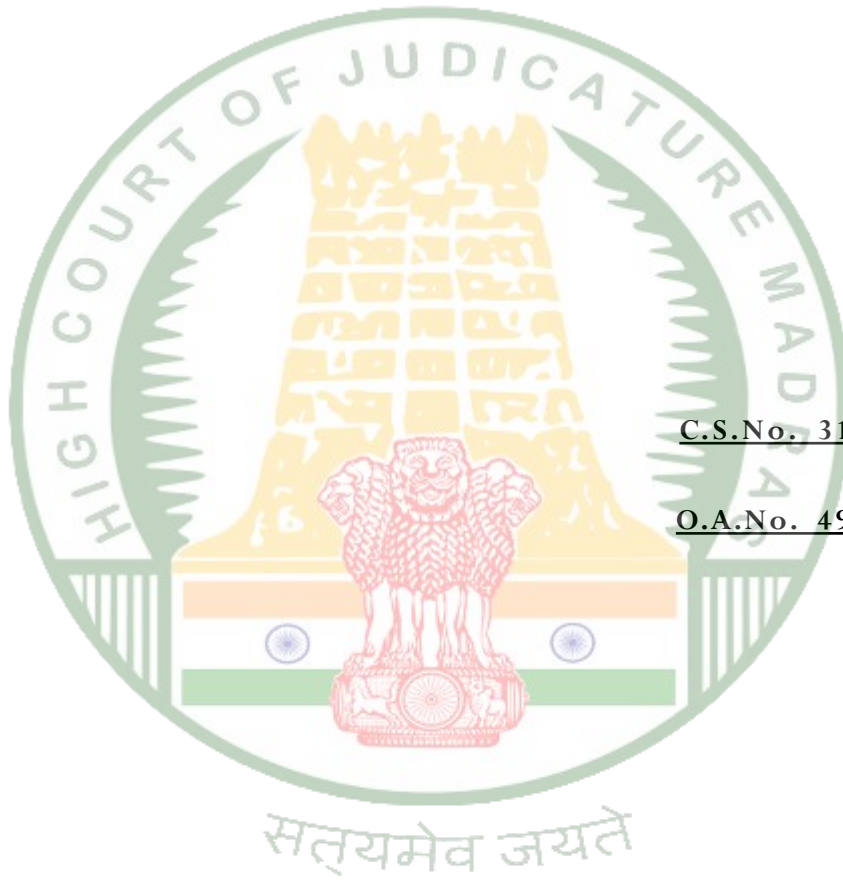
