WPs 16478 and 16479 of 2016 are filed under Article 226 of the Constitution of India praying for the issuance of Writs of Certiorari, calling for the records on the file of the respondent Notice 10: Final Assessment/ Notice 10/16-110/11517, dated 5.4.2016 and 10/16-110/11672, dated 9.4.2016, signed on 11.4.2016 and and quash the same as illegal, contrary to the provisions of the Act and against the principles of natural justice and fair play.

WP 16480 of 2016 is filed under Article 226 of the Constitution of India praying fore the issuance of a Writ of Certiorarified Mandamus, calling for the records on the file of the respondent Order in Z.O.7.R.D.C. No.R.2/07354/2015 dated 9.4.2016 signed on 11.4.2016, quash the same as illegal, contrary to the provisions of the Act and against the principles of natural justice and fair play and direct the respondent to

give credit for the entire payment of property tax of Rs.21,78,850/-.
