Learned Additional Public Prosecutor would submit that the detention order passed against the father of the petitioner in No.270/BCDFGISSSV/2018 dated 27.04.2018 on the file of the second respondent is revoked vide G.O.Rt.No.2403, Home, Prohibition and Excise (XIII) Department, dated 11.06.2018 and produced a copy of the said order.

In view of the above, this petition is closed as it has become infructuous.
