The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the husband of the petitioner herein dated 02.05.2018 has been revoked by the Government in G.O.Rt.No.2476, Home, Prohibition & Excise [X] Department dated 13.06.2018 and he has also produced a copy of the said order.
