Prayer in W.P.No.14124 of 2017: Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorarified Mandamus to call for the records relating to the proceedings of the 2nd respondent in Na.Ka.No.1006/A4/2017 dated 24.05.2017 and to quash the same and consequently direct the respondents to allow the petitioner to continue in service in Papireddipatti Union, Dharmapuri District and to resort for deployment of surplus teachers after the commencement of academic year 2017-2018 after completion of admission of students in the manner known to law.

W.P.No.13643 of 2017: Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of Certiorarified Mandamus call for the entire records relating to the proceedings of the 2nd respondent vide Na.Ka.No. 1163/A2/2017 dated 24.05.2017 and quash the same

W.P.No.13491 of 2017: Pleased to issue Writ of Certiorarified Mandamus or any other writ or order or direction in this nature of writ of calling for the entire records pertaining to the impugned order passed by the District Elementary Educational Officer Thiruvallur District the respondent herein vide his proceedings No. Na.Ka.No. 1200/ Aa5/ 2017 dated 22.05.2017 and quash the same as illegal arbitrary unreasonable being violative of rules and principles of natural justice and thereby direct the respondent to retain the petitioner as B.T. Assistant Teacher (English) at Municipal Middle School Padikuppam Villivakkam Panchayat Union;

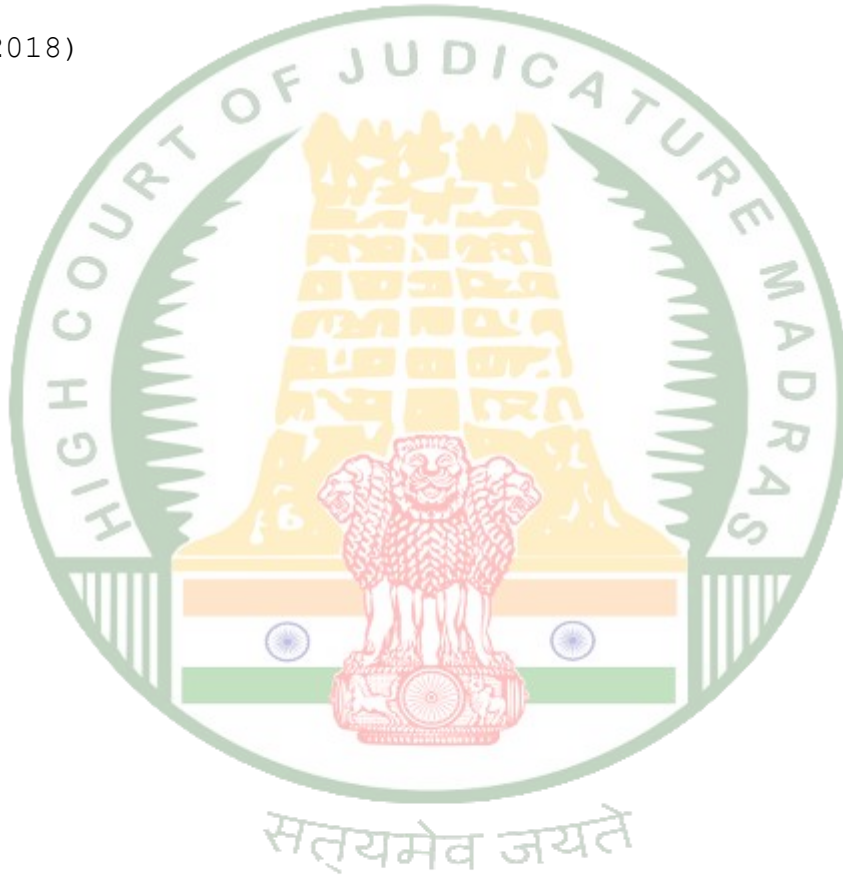
