2. Mr.K.R.Harin, learned Additional Government Pleader accepts notice on behalf of the Respondent Nos.1 to 7.

3. We direct the Respondent Nos.4 and 5 to cause a joint local inspection of the property situate at Ward M, Block-5, T.S. No.11, Patta No.1, Akkaraivattam, Navy Post, Karaikal- 609 604, within a fortnight and if any encroachment is found, the official respondents shall take action in accordance with law after putting on notice all concerned, particularly the eight respondent before us, and conclude the proceedings within two months.

The writ petition is disposed of accordingly. No costs.

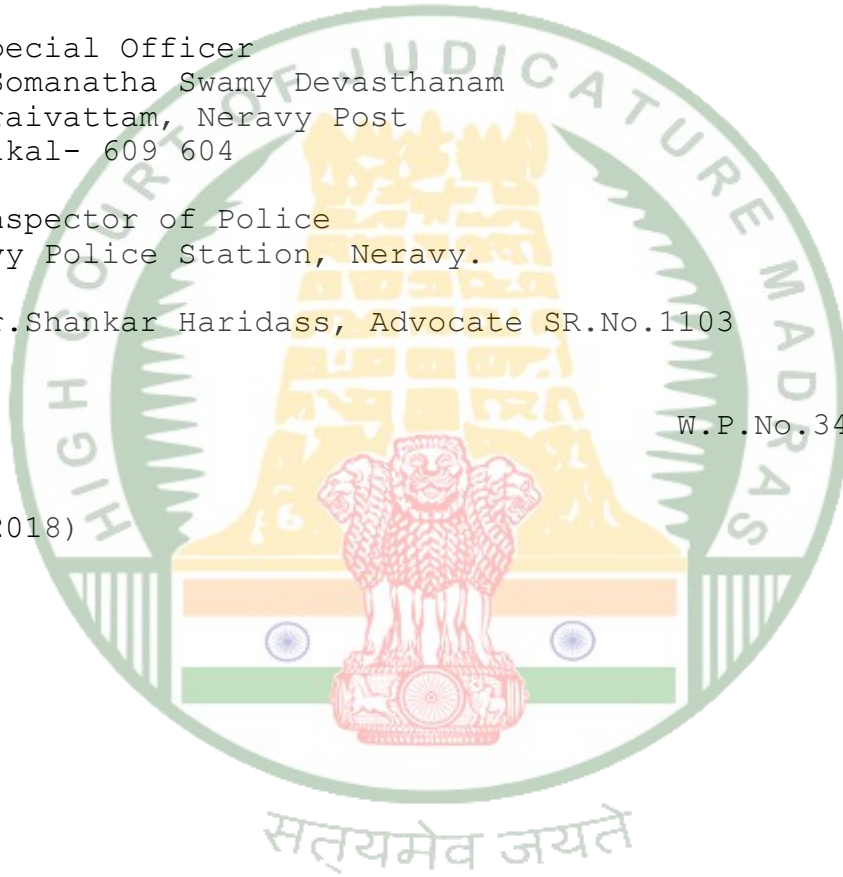
