While taking up this miscellaneous case, both the parties agreed that instead of vacate the stay, this Court may direct the Sub-Registrar, Sooramangalam, to hear the parties i.e., the writ petitioner as well as the respondent no.6 and pending

disposal of the writ petition, pass a reasonable order within a specified period.

Considering the aforesaid submission, this miscellaneous petition stands disposed of, with a direction to the Sub-Registrar, Sooramangalam, to hear both the parties i.e., the respondent no.6 as well as the writ petitioner on the protest made, afresh and pass a speaking order by taking note of the Government Circular in this regard, within a month of production of the certified copy of this order and till then, the interim order passed shall continue.
