When the matter was taken up consideration, the learned counsel appearing for the appellant submitted that the relief sought for by the appellant has been granted by the learned Single Judge in Contempt Petition No.1028 of 2018 vide order dated 21.8.2018, wherein the Government has been directed to pay the salary to the Teacher/private respondent instead of fixing the liability upon the appellant/Management and therefore, nothing survives for adjudication and has made an endorsement to that effect.

3. In view of the above, the writ appeal is disposed of. No costs. The connected miscellaneous petition is closed.
