Prayer:- Writ Petition is filed under Article 226 of the Constitution of India, seeking for a Writ of Certiorarified Mandamus, to call for the records pertaining to the order passed by the 1st respondent in Na.Ka.No.0442/2015/Pe3, dated 27.03.2015 and the order passed by the 2nd respondent in Mu.Mu.No.621/2013/A1, dated 06.01.2014 renewing the lease in favour of the 3rd respondent as the lessee of shop No.20 "DUBIDCO" Building at DDDC Buildings, Bazaar Street, near Bus Stand, Pennagaram, Dharmapuri and quash the same and direct the 2nd respondent to conduct fresh auction for the period commencing from 1.4.2015 in respect of the said shop.
