The present petition is filed by the accused in
C.C.No.4700 of 2013 pending on the file of the III
Metropolitan Magistrate, George Town, Chennai-1.

2.The learned Government Advocate(Crl.Side) would
contend that the Inspector of Police, Central Crime Branch,
Bank Fraud Team, Egmore, Chennai-600 008, after conclusion
of investigation in Crime No.662 of 2010, filed a final report
in C.C.No.4700 of 2013 before the III Metropolitan
Magistrate, George Town, Chennai-1, against the present

petitioner and since that the entire Crime No.666 of 2010 was closed by the Hon'ble Supreme Court in Civil Appeal No.165 of 2018 @ SLP (C)No.30560 of 2016, the proceedings in C.C.No.4700 of 2013 Pending on the file of the III Metropolitan Magistrate, George Town, Chennai-1, can be quashed.
