Prayer in W.P.No.30099/2012: Writ petition filed under Article 226 of the Constitution of India praying for issuance of a Certiorari thereby call upon the records of 2nd respondent in the tender No.2/2012-13 dated 05.10.2012 with regard VPH leasing for round trips in train Nos.16031/16032-Jammu-Tawi Express and quash the same as ultra vires and not maintainable in the eye of law.
