3. The learned Additional Public Prosecutor (Crl.Side) appearing for the State submitted that the petitioners are complying with the conditions regularly imposed by this Court on the petitioners.

4. Considering the facts and circumstances of the case, the condition already imposed on the petitioners is relaxed. However, the petitioners shall appear before the respondent police as and when required for interrogation on receipt of summons. This petition is ordered accordingly.
